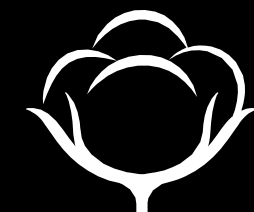
In 2015, Stefan Brandt set a new milestone with the revolutionary "15-step pre-fit treatment".

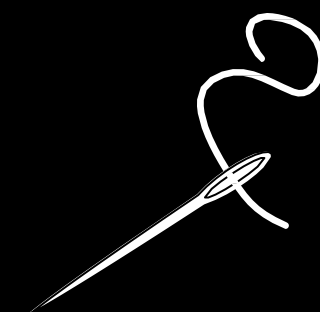
